

Bylaw 03-2017

**A BY-LAW OF THE TOWN OF HIGH PRAIRIE, PROVINCE OF ALBERTA, FOR THE PURPOSE OF CLOSING A PORTION OF A PUBLIC ROADWAY IN ACCORDANCE WITH SECTION 22 OF THE MUNICIPAL GOVERNMENT ACT, CHAPTER M-26 REVISED STATUTES OF ALBERTA 2000 AS AMENDED**

- WHEREAS,** the lands hereafter described are no longer required for public travel; and
- WHEREAS,** application has been made to Council to have the highway closed, and
- WHEREAS,** Council deems it expedient and proper to provide a bylaw for the purpose of closing to public travel certain roads, or portions thereof, situated in the Town of High Prairie, and thereafter creating title to and disposing of same; and
- WHEREAS,** notice of the intention of Council to pass a bylaw has been given in accordance with Section 606 of the Municipal Government Act; and
- WHEREAS,** Council was not petitioned for an opportunity to be heard by any person claiming to be prejudicially affected by the bylaw.

**NOW THEREFORE,** under the authority and subject to the provisions of the Municipal Government Act, being Chapter M-26.1, of the Statutes of Alberta, 2000, and amendments thereto, the Municipal Council of the Town of High Prairie, in the Province of Alberta, duly assembled, enacts as follows:

1. PLAN 2000KS  
ALL THAT PORTION OF THIRD STREET AND WEST STREET LYING NORTH OF THE PRODUCTION EASTERLY OF THE SOUTHERLY BOUNDARY OF LOT 'A' OF SAID PLAN  
CONTAINING 0.270 HECTARES (0.67 ACRES) MORE OR LESS  
EXCEPTING THEREOUT ALL MINES AND MINERALS
2. That this Bylaw shall take effect on the date of final passing thereof.

This By-Law shall come into force and effect upon third reading thereof.
