

A Bylaw of the Town of High Prairie in the Province of Alberta, pursuant to the provisions of the *Municipal Government Act, Revised Statutes of Alberta 2000, Chapter M-*26 (MGA) to establish rates, fees, and charges for various licenses, permits, goods and services provided by or on behalf of the Municipality.

**WHEREAS,** pursuant to the MGA, a municipality has the authority to establish fees and charges for the provision of good and services;

**AND WHEREAS,** Council deems it appropriate to establish rates, fees and charges for the various licenses, permits, goods and services provided by or on behalf of the Town of High Prairie;

NOW THEREFORE, the Council of the Town, duly assembled, enacts as follows:

#### 1. TITLE

1.1 This Bylaw may be cited as the "Fees Bylaw".

#### 2. **DEFINITIONS**

- 2.1 In this Bylaw:
  - a) "CAO" means the Chief Administrative Officer or designate, appointed pursuant to the MGA;
  - b) "Council" means the Council of the Town;
  - c) "Fire Department Unit" means any vehicle within the High Prairie Fire Department Fire Hall that is over the ½ ton rating and equipped with fire suppression or extrication tools.
  - d) "MGA" means the Municipal Government Act, Revised Statutes of Alberta 2000, Chapter M-26; and
  - e) "Rates" means the tariff of charges for services as set out in Schedule A.
  - f) "**Town**" means the municipal corporation of the Town of High Prairie.

#### 3. GENERAL INTERPRETATION

- 3.1 All schedules attached to this Bylaw form part of this Bylaw.
- 3.2 Headings or subheadings in this Bylaw are inserted for ease of reference and guidance purposes only and do not form part of this Bylaw.
- 3.3 Words in the singular include the plural and words in the plural include the singular.
- 3.4 Where this Bylaw cites or refers to any act, regulation, code or other bylaw, the citation or reference to the act, regulation, code or other bylaw includes any amendments thereto before or after the commencement of this Bylaw, and includes

reference to any act, regulation, code or other bylaw that may be substituted in its place.

- 3.5 Each provision of this Bylaw is independent of, and severable from, all other provisions and if any provision is declared invalid or unenforceable for any reason by a court of competent jurisdiction, all other provisions of this Bylaw remain valid and enforceable.
- 3.6 Nothing in this Bylaw relieves a person from complying with any provision of any federal, provincial or municipal law or regulation or any requirement of any lawful permit, order or license.

#### 4. APPLICATION

- 4.1 This Bylaw establishes Rates, fees and charges for certain goods and services provided by or on behalf of the Town as set out in Schedule A and subject to applicable taxes where appropriate.
- 4.2 Where this Bylaw establishes a Rate, fee or charge that also exists in another bylaw or policy that predates the effective date of this Bylaw, the Rate, fee and charge in this bylaw shall be the applicable bylaw and the other bylaw or policy is hereby effectively amended.
- 4.3 Where Schedule A does not list a certain good or service to be provided by or on behalf of the Town, the CAO shall apply a Rate, fee or charge that is similarly aligned with the theme of this Bylaw. This Rate, fee or charge is subject to applicable taxes where appropriate.

#### 5. REPEAL

5.1 This Bylaw rescinds Bylaw No. 02-2021. Bylaw No. 02-2021 is hereby repealed effective 11:59 p.m. December 31, 2021.

#### 6. COMING INTO FORCE

6.1 This Bylaw shall come into force and effect on January 1, 2022 upon third reading.



#### **Examples of SSC Permit Fees for New Construction**

**Example 1 -** \$50,000.00 (\$4.00 per every \$1,000 of Construction Value)

#### **Calculate as Follows:**

 $$50,000/1,000=$5,000 \times 4 = 200 \times 4\% = $8.00$  SSC Permit Fee = \$200.00 plus \$8.00 SCC Levy = \$208.00

**Example 2 -** \$1,625,000.00 (\$4.00 per every \$1,000 of Construction Value)

#### **Calculate as Follows:**

 $$1,625,000/1,000=$1,625 \times $4.00 = $6,500 \times 4\% (SCC Levy) = $260.00 SSC Permit Fee: $6,500 plus $260 SCC Levy = $6,760$
