In past years public delegations of specific interest have been encouraged to forward a summary of their issue(s) to administration for inclusion in the agenda a week in advance of the next meeting of Council.

ELIGIBILITY CRITERIA:

- a) This policy shall apply for a hearing of any and all delegations by residents of the Town of High Prairie at the discretion of the Council of the day.
- b) Council, through the Mayor or Deputy Mayor will advise and allow all groups present at the start of a regular meeting to share in a 15 minute period set aside for this purpose.
