An agreement be effected between the Town of High Prairie, the East Prairie Metis Settlement, the Gift Lake Metis' Settlement, the Municipal District of Big Lakes and such other local Government bodies as may be approved by the representatives of the participating parties pursuant to the terms of the said agreement, to allow for the formation and operation of a Regional Waste Management Authority., The Administration of the Municipal District of Big Lakes is authorized to approve and execute amendments to the said agreement if recommended by the participating parties."
