

BYLAW 11/2017

A BYLAW OF THE MUNICIPALITY OF THE TOWN OF HIGH PRAIRIE IN THE PROVINCE OF ALBERTA, TO REPEAL OBSOLETE OR REDUNDANT BYLAWS

WHEREAS Council recognizes that the original mandate of the selected bylaws has been fulfilled,

WHEREAS Section 63(1) 2(b) of the Municipal Government Act states a council may by bylaw authorize the revision of all or any of the bylaws of the municipality. The bylaw may authorize the following: omitting and providing for the repeal of a bylaw or a provision of a bylaw that is inoperative, obsolete, expired spent or otherwise ineffective.


THEREFORE THE COUNCIL OF THE TOWN OF HIGH PRAIRIE, duly assembled in open meeting assembled enacts as follows:
